EACH YEAR BMWF ENGAGES AN AVERAGE OF 304 VOLUNTEERS, AGES 12 TO 80, IN CONSERVATION PROJECTS. PROJECTS INVOKE A SENSE OF PRIDE FOR MONTANA'S MOST TREASURED LANDSCAPE. BOTH YOUTH AND ADULT VOLUNTEERS HAVE LIFE CHANGING EXPERIENCES.
